Network of Victim Assistance Receives Funding for Community Awareness Events

Candlelight Tribute & Yoga Scheduled for National Crime Victims' Rights Week

(BUCKS COUNTY, Pa.) Network of Victim Assistance (NOVA) is pleased to announce that it has received funding from the National Association of Victims of Crime Act Assistance Administrators (NAVAA) for two events that will take in April to commemorate National Crime Victims' Rights Week (April 19-25). The events are NOVA's Annual Candlelight Tribute for Victims of Crime on April 21 and a free Community Yoga Event on April 25. The funding was provided by way of a grant from the U.S. Department of Justice Office for Victims of Crime (OVC). The OVC administers the Crime Victims Fund, which is financed from fines and penalties paid by convicted federal offenders. Out of 262 applications submitted nationwide, NOVA was one of 109 victims' rights organizations that was recommended by NAVAA and selected for funding in 2020 by the OVC.

available to people who have been victimized by crime.
